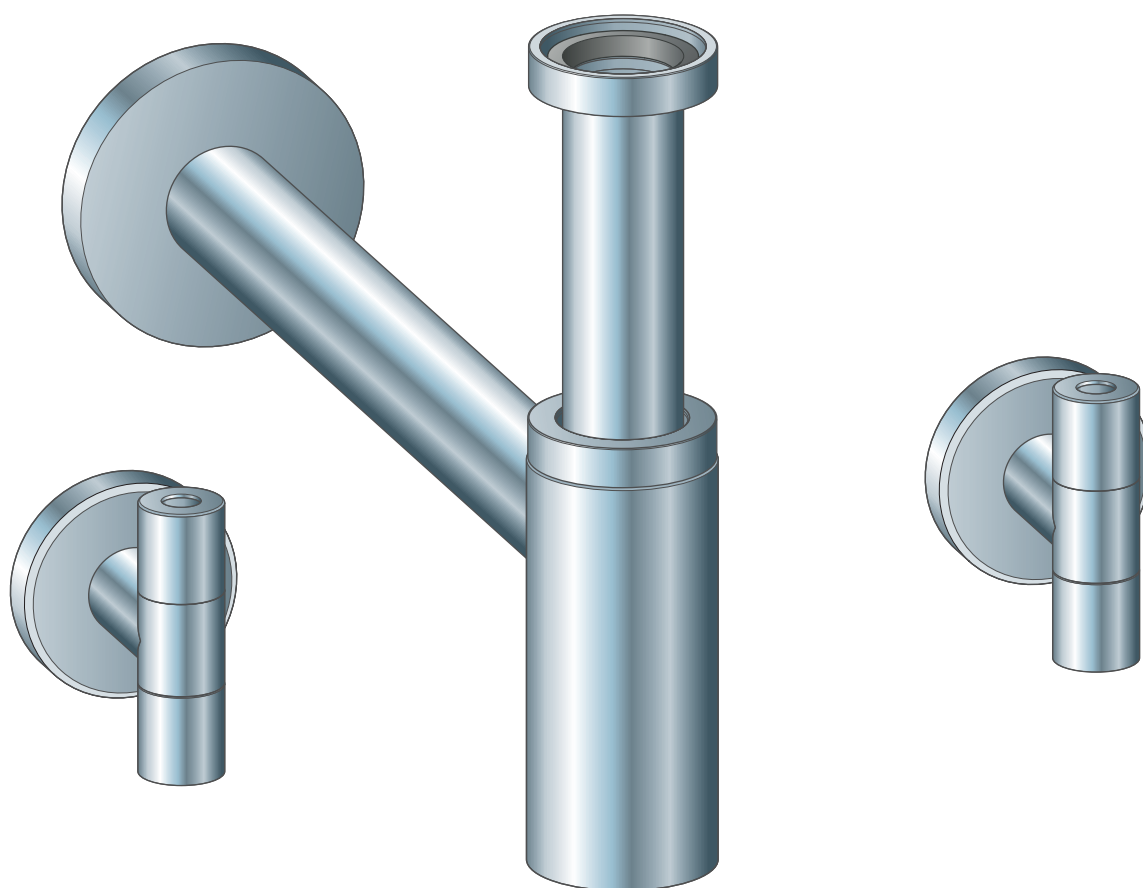

Risk of damage due to unsuitable liquids

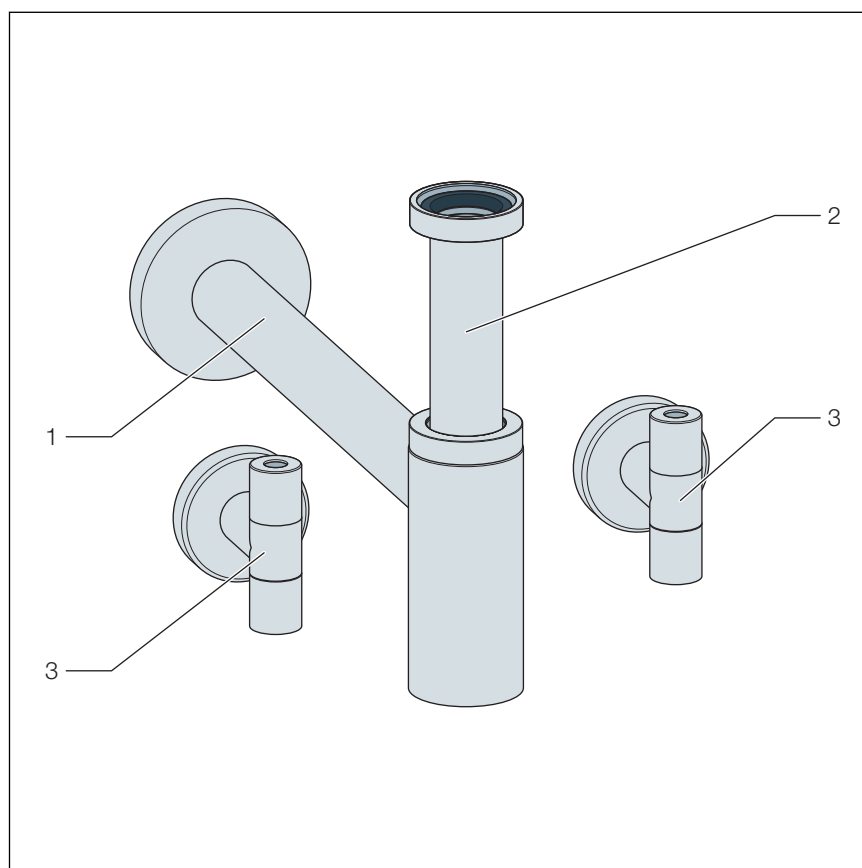
To avoid damaging the drain, only introduce the following liquids:

- Typical household wastewater with temperatures up to 95 °C
- The pH value must be higher than 4 but lower than 10.

The Eleganta bottle odour trap is suitable for washbasins with 1¼ inch connection.

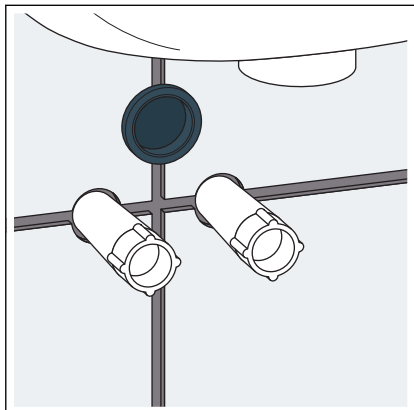
- 1 Eleganta pipe
- 2 Bottle odour trap with cup
- 3 Corner valves

DN (nominal width) outlet pipe	DN 32 mm
Drain elbow connection	1¼
Water seal level	50 mm

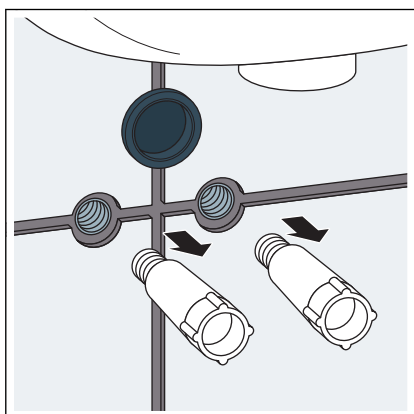
3.2 Assembly

3.2.1 Mounting corner valves

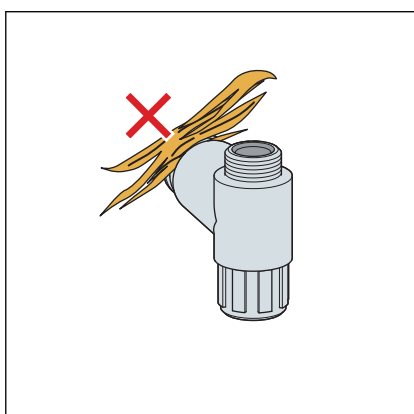


Requirements:

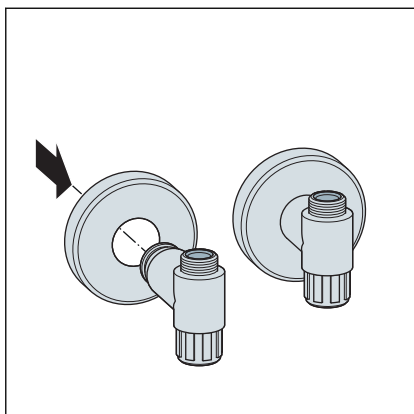
- The washbasin is mounted.
- The drain pipeline is installed.
- The water supply is closed.



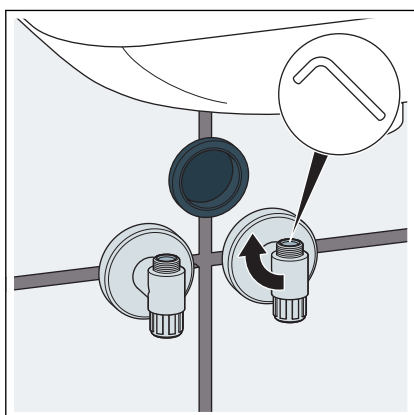
➤ Remove the plugs.



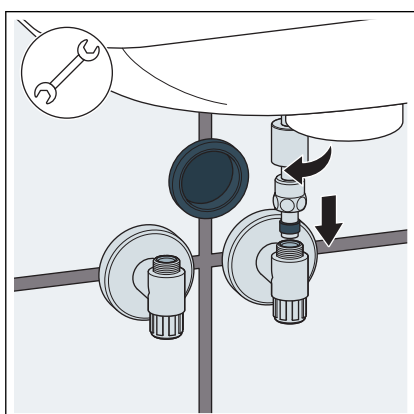
➤ Do not seal the angle valves.
The valves have a factory-applied seal.



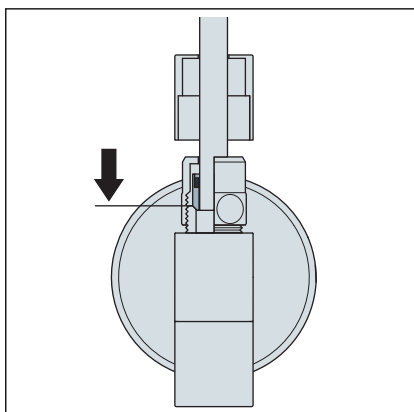
➤ Push on the cover rosettes.



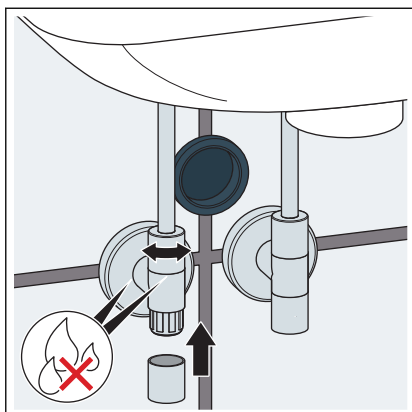
➤ Screw in the corner valves.



➤ Push the cover, the fixing screw and the sealing element onto the connection pipe.



➤ Push the connection pipe in as far as it will go and screw it in place.

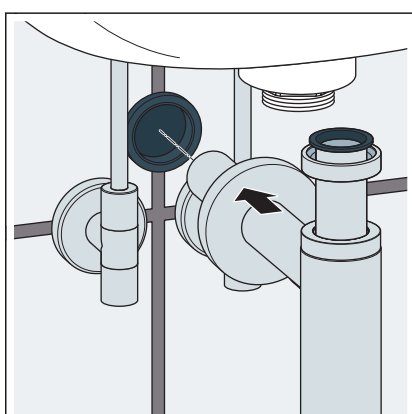
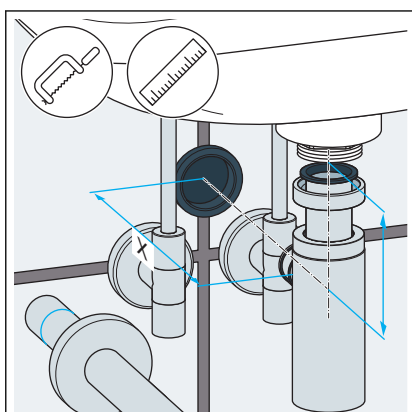


- Open the corner valve and check for leaks.
- Slide on the cover.

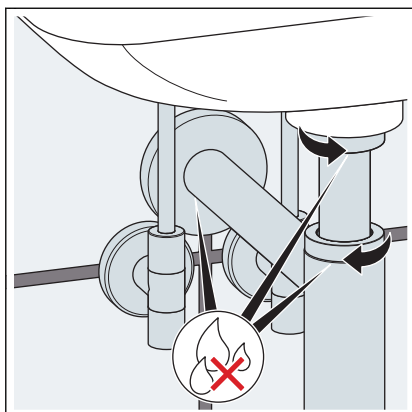
3.2.2 Mounting the bottle odour trap

Requirements:

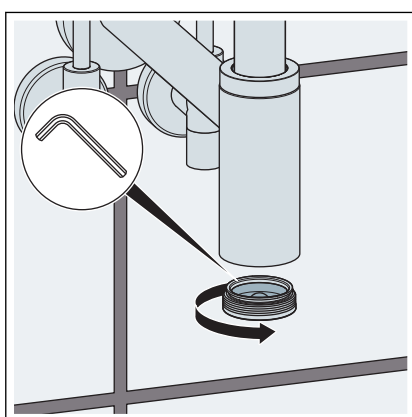
- The washbasin is mounted.
- The drain pipeline is installed.
- The corner valves are mounted.
- Mount the adjusting pipe with the union nut.
- Measure the installation height and depth.
- Shorten the drain pipe and the adjusting pipe if necessary.
- Ensure sufficient insertion depth.



- Insert the odour trap.
- Push the drain pipe onto the odour trap.
- Ensure that the sealing elements are correctly seated.
- Fit the cover rosette.



- Tighten the fixing nuts.
- Check the odour trap for leak tightness.



- Screw in the plug.

3.3 Care



NOTICE! **Risk of damage due to unsuitable cleaning agent.**

The following cleaning agents can damage chrome-plated surfaces and therefore may not be used:

- Scouring agent
- Abrasive sponges
- Lime, plaster or cement dissolver
- Solvents or other acidic cleaning agents

Use household cleaner to remove coarse soiling, also around the odour trap. Rinse the detergent thoroughly with clear water after the prescribed exposure time. There should be no residue on the components.

3.4 Disposal

Separate the product and packaging materials (e. g. paper, metal, plastic or non-ferrous metals) and dispose of in accordance with valid national legal requirements.
