2.2 Intended use

2.2.1 Areas of use

The Viega sink basin module is suitable for mounting on wall constructions pursuant to the regulations in section *„Regulations from section: Fields of application / Mounting conditions“ on page 6* and is intended for use in a Steptec pre-wall construction.

2.3 Product description

2.3.1 Overview




Fig. 1: Scope of delivery

- 1 - slot nut
- 2 - sink basin
- 3 - mounting bracket for drain elbow
- 4 - drain elbow

2.3.2 Compatible components

The module is compatible with all common sink basins.

2.3.3 Sound protection

The sink basin element complies with the noise insulation requirements specified in section **„Regulations from section: Sound protection“ on page 6**.

3 Handling

3.1 Assembly information

3.1.1 Mounting conditions

Suitable walls

For this, observe the Steptec system instructions for use.

Construction height

With the construction height, the marked height of the upper edge of the finished floor must be observed.

3.1.2 Installation dimensions




Fig. 2: Dimensions

3.1.3 Required tools

The following tools are required for mounting:

- fork or ring spanner: 17 mm / 19 mm
- Phillips-tip screwdriver

3.2 Assembly

3.2.1 Mounting module


Mounting in Steptec



The two vertical rails, which surround the module, must be open towards the module and be at an interval of 430 mm.

- ▶ Secure the module onto the open Steptec rail with the slot nuts supplied:


- ▶ Insert the slot nut into the opening.





- ▶ Push the slot nut in slightly.
- ▶ Turn by 90°.
⇒ The slot nut is secured in the Steptec rail.




- ▶ Align the height of the module.
- ▶ Tighten the slot nut with a ring spanner (SW 17).



- ▶ Tighten the other slot nuts in the same way.
 - ⇒ The module is secured on the rail framework.
- ▶ Place the drain elbow in the intended bracket.
- ▶ Close the bow around the drainpipe.
- ▶ Set the desired height for the drain elbow.
Tighten the screws with a Phillips screwdriver.




- ▶ Check height settings.
When doing so, observe the sink basin's manufacturer's instructions (X).
- ▶ Make sure that the fixing ends flush with the rail framework. The fixing may extend for a maximum of 1.5 mm beyond the rail framework.



INFO! Do not unscrew the screws completely.

- ▶ Set the distance from the drain elbow to the sink basin module using the two middle screws on the module.
To do this, loosen the screws slightly and set the desired height.
Re-tighten screws.

3.2.2 Rounding off jobs



- Single clad pre-wall: Clad with 12.5 mm wide IFGP or 12 mm wide Aqua-KS cladding panels.
When doing so, make sure that no abutting edges converge.
- Grout the abutting edges and joints with a suitable filler.
- Observe the instruction manual for the cladding panels for more information.

3.3 Disposal

Separate the product and packaging materials (e. g. paper, metal, plastic or non-ferrous metals) and dispose of in accordance with valid national legal requirements.
