




2.1 Intended use

The Prevista Dry Plus-pipe holder set is intended for fastening threaded rods and pipe clamps.

2.2.1 Overview




- 1 Plug-in piece
- 2 Tendon
- 3 Strap

The pipe holder set made of galvanized steel is equipped with two M8 threads for the attachment of threaded rods and pipe clamps.

Fig. 1: Pipe holder set


2.2.2 Compatible components

Mounting rails



The mounting rail made of galvanized steel is 5 m long, open on one side and perforated every 30 cm for wall and floor mounting.






Fig. 4: Fixing distances

3.2 Assembly


3.2.1 Installing the pipe holder set




- If necessary, slightly compress and move the tendon.




- On the open side of the mounting rail, mount the pipe holder set with the plug-in piece on the rail (SW 5).



- On the closed side of the mounting rail, remove the plug-in piece of the pipe holder set.
- Mount the pipe holder set on the closed side (SW 5).



- If necessary, cut the protruding part of the pipe holder to length with a hacksaw.



- Mount the threaded rod and the clamp.
- Lock with two M8 threaded nuts.

3.3 Disposal

Separate the product and packaging materials (e. g. paper, metal, plastic or non-ferrous metals) and dispose of in accordance with valid national legal requirements.
